IV. DESCRIPTION

- Rescue lifting and lowering device class B, with stainless steel wire rope, of diameter 6.3mm, length from 5m to 20m. A thimble sleeved buckle on the end of the wire cable with a connector reference AZ011, an absorbing spring reference SDW.00.01 and a winch absorber reference SDW.00.00 and a connector reference AZ011. The wire cable pass through the pulley reference RUP-502-xx. Maximal working load: 140kg

V. REFERENTIAL

- The assessment of conformity was conducted taking into account the provision of European standard EN 1496 of November 2006 " Rescue equipment – Rescue lifting devices".

VI. Conclusion
